



WeBuyCars Pre-Owned Leisure Warranty

PRODUCT DESCRIPTION:

This policy provides cover against mechanical and/or electrical failure of leisure goods. It covers boats, jet skis, caravans and trailers. Please note that this policy does not cover every eventuality and hence you need to fully understand what cover is provided under this policy.

This is a summary of the policy benefits, terms and conditions. The full policy wording will be provided to you should you wish to purchase a warranty policy.

QUALIFYING CRITERIA

Your Leisure Goods must be a boat, jet ski, caravan, or trailer.

For boats and jet skis:

- A maximum of 2 motors (inboard/outboard) per policy.
- Be less than 10 years old from the date the original buoyancy certificate was issued.
- Have a pre-delivery inspection report.

For caravans and trailers:

- Be less than 10 years old from the date of original registration.
- Have a pre-delivery inspection report.
- Be roadworthy.

EFFECTIVE DATE AND DURATION

Cover commences on the purchase date of the item and provides cover for 24 months.

- Where a boat or jet ski/s are covered together with a trailer, the trailer is considered part of the Leisure Goods and does not increase the aggregate claims limit.



- A maximum of two (2) jet skis may be covered under the aggregate benefit limit.
- Cover and claims payable only applies to the original trailer, boat or jet ski/s specifically listed and described in the policy documentation.

SERVICING YOUR LEISURE GOODS

- You need to have Your Leisure Goods serviced and maintained as per the Manufacturer's specifications at an Administrator Approved Dealer or Independent Service Provider.
- If Your Leisure Goods does not have an up-to-date service history, you need to make sure it gets serviced within 30 days after buying this Policy. This service must follow the Manufacturer's guidelines based on Your Leisure Good's age at the time, and You will need to cover the costs of this service.
- While allowance is made for deviations from the Manufacturer's specifications in terms of servicing in time, you should not exceed the specified limit.
- After each service, the appropriate service record must be completed. Make sure that the service is recorded in the Leisure Good's Service Book. If Your Leisure Goods does not have a service book, you must retain copies of the job card, invoice and receipt for each completed service.
- Not following these service requirements could result in a claim not being paid and Your Policy being cancelled.
